Council member Bemenderfer provided an update on the website committees progress on selecting a new vendor. He also reported that the EDA is working on 2018 goals and priorities with strategic direction.

Council member Hallquist reported on the Discover Dassel committee's beautification project at Hwys 12 & 15 and the Dassel Dazzle event scheduled on December 8<sup>th</sup>.

Council member Weseloh invited everyone to get involved and become a Red Rooster volunteer.

The council scheduled a public hearing to be held on December 18<sup>th</sup> immediately following the Truth in Taxation hearing on a petition to vacate a public easement on Lots 1-3, Block 8 and Lots 27-33, Block 3 by Carl Rokala.

Motion by Carlson, seconded by Bemenderfer to pro-rate the liquor license fees for Thirsty's Tavern as allowed by City Code Section 110.06. Motion carried unanimously.

Motion by Carlson, seconded by Weseloh to conduct a state background investigation check on the new owners of Thirsty's Tavern, in conjunction with issuing their liquor licenses, and refund any fees not expended for the investigation from their \$300 deposit. Motion carried unanimously.

The council review the monthly Waste Management recycling report which showed a of 7.15 tons recycled in September.

Attorney Greenley provided an update on the Crow Castle cell tower request to add transmission equipment on the Sharel Lee property. A letter will be sent requesting additional information.

Chief Grochow stated there were 29 calls for the month of October. He asked the council to consider accepting the donation of a 25kw generator from the City of Cokato. The generator was at the old fire hall and is being replaced with a new generator at their new building. He discussed the need for a slab and potential building or fencing around the generator at the fire hall. Clerk Boese will pursue funding for moving/relocating/housing and/or hookup of the generator through Meeker County Emergency Management. Grochow informed the council they are still pursuing a FEMA grant for the SCBA equipment. There have been several issues with the SAM's website.

### Liquor Store Manager

Manager Vetsch manager reported sales for October were \$90,267.76, an increase of 5% over last October. He stated sales are still moving in a positive direction and they are setting displays for the holiday season.

### Museum Director

Director Holje reported on the following upcoming events:

Dinner theatre will be a Bait and Hook Dec. 9.

#### **Exhibits**

It is about adaptation and roots. Two cartoon artists from Sweden will present a short program on Nov. 28 about the exhibit. That will be the opening. Cartoons, photos, text etc. In 2014 they were in the Midwest interviewing people of Swedish heritage about their lives. The exhibit has been in many places in Sweden; now they are bringing it back to the US.

### Mamie Falk's paintings are on display

Two of the originals were donated by the City. One original by someone from Minneapolis. Nine framed prints have been donated. They are interesting pieces. Falk is somewhat known as the "Grandma Moses of the Midwest." She has Dassel connections.

#### **Public Works Director**

Director Zwilling reported that the loader has been repaired and is back. The effluent discharge for the year was 58.4 million gallons. Spraying for mosquitos was discussed and he will get cost estimates. Public works will be sweeping the streets one more time before winter.
