_____ I have received, read, and fully understand the material contained within § 94.04A of the Dassel City Code of Ordinances titled **KEEPING OF CHICKENS ON RESIDENTIAL PARCELS WITHIN THE CITY.**

_____ I agree to abide by the conditions for keeping chickens as set forth in § 94.04A of the City Code of Ordinances. These conditions include but are not necessarily limited to the following:

1. No roosters are permitted. All chickens must be hens. If a permit holder inadvertently keeps a rooster, then that rooster must be removed from the parcel within seven (7) days of discovery.
2. Chicken food is to be kept in rodent and pest proof containers designed to prohibit access by rodents or other pests.
3. A run or exercise yard conforming to this section is required.
4. Chickens must not be kept in such a manner as to constitute a nuisance to the occupants of any adjacent property.
5. Dead chickens must be disposed of according to applicable law and must be removed immediately and in any event within twenty four (24) hours.
6. Chicken manure is to be contained in a weather and pest proof container and removed weekly or used as fertilizer and regularly incorporated into the soil.
7. Chickens kept under this subdivision may not be slaughtered within the City.
8. No more than five (5) chickens may be kept at any one parcel at any time unless parcel is over one (1) acre, in which ten (10) may be kept.
9. Chickens must be confined inside a stationary/portable coop or a fenced in run at all times and may not be allowed to range freely.

_____ I have attached a to-scale sketch of the shape and dimensions of the proposed chicken coop and run, and their proposed location on applicant's parcel. (If the coop/run are portable, the sketch must designate an area within which the portable coop/run will be maintained.) This sketch also includes the location of applicant's property lines, the location of all dwellings on applicant's parcel, and the location of dwellings on all adjacent parcels. The sketch contains measurements between the closest point of the coop/run to the closest point of each property line and each dwelling.




